Dance Theater Performances: Conceived, developed, and presented public performances for the general public in venues in Chicago and Houston including Ruth Page Center for the Arts (Chicago), MATCH - Midtown Arts and Theater Center Houston, Winter Street Studios, and San Jacinto College. Performances included "Whirl!," performed at Harvest Contemporary Dance Festival Chicago, "Stories to Tell," a repertory concert featuring the work of Open Dance Project artistic director, company members, and guest artists; "Magician's Nephew," a performance for family audiences featuring Aerial silk work, dance, and theater; and "At the Station," a new work for young dancers choreographed by Open Dance Project to benefit "Artists for Hope," a dance community event for housing of families living with chronic illness.

Dance Theater Educational Programming: Developed and led classroom workshops, residencies, performances, and professional development workshops (teacher trainings) in Houston area schools and after school programs. Classroom workshops and residencies focused on teaching collaborative composition techniques to school children through the development of original dance theater performances based on STEM curriculum matter. Teacher trainings in collaboration with the Houston Arts Access Initiative, dedicated to bringing equity in arts education to schools Houston Independent School District, focused on sharing dance theater education strategies with classroom teachers for use in lesson planning and teaching in their classrooms. Open Dance Project School Performance offerings for 2016 included the development of "ENGINuity" inspired by the invention and inner workings of various kinds of engines and "Staging Story Live" where Open Dance Project artists use the ideas of the student audience to generate an all new dance theater performance using dance, theater, and live music. Summer educational programming included a collaboration with Memorial Hermann Hospital and Hogg Middle School targeting childhood obesity through dance.

Guest Artist Residencies/Artist Exchanges: Hosted master classes open to the public by dance artists Polly Motley, Eoghen Dillan, Amy Morrow, Jane Weiner, and Patrick Mueller. Commissioned a new work by choreographer and director of Control Group Productio Patrick Mueller, which was developed in collaboration with Open Dance Project dancers and performed in November 2016 at MATCH in Houston for the general public. Presented danceworks by guest choreographers Jennifer Mabus and Alisa Mittin.
