Performances included: the evening length, multimedia, immersive performance, "'Bout a Stranger;" "Bodies in Motion" featuring new works developed in collaboration with Musiqa; & "The Lion, the Witch, & the Wardrobe: a performance for family audiences featuring aerial silk work, dance, & theater.

Teacher trainings in collaboration with the Houston Arts Access Initiative, dedicated to bringing equity in arts education to schools in the Houston Independent School District, focused on sharing dance theater education strategies with classroom teachers for use in lesson planning & teaching in their classrooms. Open Dance Project School Performances for 2017 included "ENGIN-uity," inspired by mechanics & history of the engine & "Staging Story Live" where Open Dance Project artists use the ideas of the student audience to generate an all new dance theater performance using dance, theater, & live music.
